A financial report for the LTA was presented by Jim Jenkins:

Last year resulted in a deficit of about \$3000 primarily due to the LTA donating a trap machine to TBMGC in order to host the state shoot. This year the LTA invested in new shooting software, computers and printers. With the savings from not having to pay Mike Freeman, a donor and the fees collected from Pre-squad, the cost of this was covered. A major event donor was lost but an anonymous Donor, preliminary event donors LA Hunters for Heroes and Kiper Farms, and open event donor Danny Batten were added. The dinner donor was also lost and the LTA decided to donate the Saturday dinner to the shooters. With the additional day of shooting and higher attendance, it appears that the LTA will break even for the year. It was noted that some of the long-term donors are committed to continuing their donations but are aging. The membership was requested to look for additional event donors.
